2013 ASLA ANNUAL MEETING AND EXPO

Our annual meeting is November 15 -18 at the Boston Convention and Exhibition Center. ASLA will continue to provide an emeritus registration category that was implemented in 2007 to better serve its retired members, many of whom are Fellows. Emeritus members of ASLA will be able to register for the Annual Meeting for only \$370. If they book their hotel room at one of the official meeting hotels when they register, this rate is reduced to \$295. Please be advised that hotels are going quickly so please book your room soon. CONTRIBUTING TO THE COUNCIL OF FELLOWS SCHOLARSHIP

As we reported in the spring newsletter, as of December 2012, the scholarship fund balance was \$266,000, which exceeds the initial goal of \$250,000. This is a real accomplishment given the economic market of the last four years. In 2012, Fellows contributed just under \$13,000, awarded two \$4000 scholarships and paid \$2,000 to LAF as a management fee. What is our next goal? As the scholarship fundraising continues, we hope to have full participation from all ASLA Fellows, at any level. The [pledge form](#) is available on the ASLA website.

Beginning in 2013 we have also initiated the ASLA Fellows Endowment Fund. This planned giving campaign will help to fund scholarships and programs for future generations.
