## Honorary Membership Nomination Narrative

Nominee: The Hon. Robert A. Peck, Commissioner

Public Buildings Service

U.S. General Services Administration

Nominator: Thomas R. Tavella, FASLA

Some of the best news last year for the landscape architecture profession—and for the design industry in general—was that President Obama appointed Robert A. Peck to be his Commissioner of GSA's Public Buildings Service (PBS). Bob had held this position from 1996 until 2001 for President Clinton, with much success. He is the first PBS Commissioner who has recognized the importance of federal landscape architecture and the role of landscape architects. There is no public servant more devoted to achieving design excellence in the public realm and it is a privilege for me to nominate him for honorary membership in our Society.

As PBS Commissioner, Bob heads the agency responsible for the nationwide asset management, design, construction, leasing, building management and disposal for 354 million square feet of government-owned and leased space, accommodating one million federal workers. Additionally, he oversees an annual budget of more than \$8 billion and a workforce of 6,300. Between his terms as PBS Commissioner, Bob served as president of the Greater Washington Board of Trade and as a managing director of Jones Lang LaSalle, where he advised corporations, governments, and nonprofit institutions on real estate portfolio strategy and on public-private, mixed-use developments.

His prior federal experience includes positions at the Office of Management and Budget, the National Endowment for the Arts, and the Federal Communications Commission. He was associate counsel to the Committee on Environment and Public Works and Chief of Staff to the late U.S. Senator Daniel Patrick Moynihan. He has also been vice president for public affairs at the American Institute of Architects (AIA).

Bob served as a Special Forces officer in the U.S. Army Reserve. He is a past president of the D.C. Preservation League, a former appointee to the D.C. Board of Education, and has served on numerous other public and nonprofit boards. Bob holds a bachelor's degree in economics from the University of Pennsylvania, a Juris Doctor from Yale Law School, and was a Loeb Fellow at Harvard University's Graduate School of Design.

#### An Advocate for Design Excellence in the Public Realm

Bob's passionate advocacy for public design dates back to his work for Sen. Moynihan, for many years the Senate's arbiter of public works. He contributed to the landmark book, *The Federal Presence: Architecture, Politics, and Symbols in U.S. Government Building*, published by the National Endowment for the Arts in the early 1980s, which upheld the philosophy that the values of nation are reflected in its public buildings.

As vice president of AIA, Bob helped redirect federal transportation policy from highway construction to multi-modal transportation solutions that fit the needs of each community. The Intermodal Surface Transportation Act (ISTEA) restructured funding formulas to give states and communities incentives to invest in planning, public transportation, intermodal solutions, and transportation enhancements. Bob authored much of the language that turned what had previously been known as "The Highway Bill" into a national transportation policy. He helped organize the Livable Communities Coalition and the Surface Transportation Policy Project. Bob invited ASLA to join these groups as a founding member, recognizing the vital role landscape architects play in creating successful surface transportation projects.

In his first term as PBS Commissioner, just after the Oklahoma City bombing, Bob worked with ASLA on security design, acknowledging that the most of the best tactics for preventing crime or terrorist actions lay in the landscape. GSA co-sponsored ASLA's two symposia on security design and incorporated many of the findings into federal guidelines and policies. In 2000, Bob signed a partnering charter between GSA and ASLA publicly acknowledging the important role of landscape architecture in successful federal projects and outlining broad areas of collaboration between the agency and the Society. Eventually, this led to federal procurement opportunities for landscape architects to receive prime contract awards.

### A Leader in Sustainability

Now that Bob is back in what he calls "the best job in real estate" he is turning his focus to green building technologies and pushing GSA demonstrate innovative sustainable solutions in its projects in communities across the nation. GSA received \$5.55 billion to spend on public buildings under the American Recovery and Reinvestment Act, to convert federal facilities into high-performance green buildings, as well as to build new energy-efficient federal buildings, courthouses, and land ports of entry. Bob says this not only means creating jobs, but "turning the money into energy-conservation outcomes in public buildings" and leaving "a long-term legacy" for the country.

Knowing Bob, GSA will use these resources to launch a program of continuous innovation, becoming a green proving ground, testing and demonstrating strategies as models for the industry, rather than the other way around. Although he's only been back in office since last August, he's already announced renovation of the 18-story federal building in Portland, Oregon, with a vertical green wall on one entire side, low flow fixtures, and recycled roof water. And I think he's just getting warmed up.

Many people are smart, *or* educated, *or* effective, but Bob Peck is all three. Our nation is very fortunate to have him back in public service where his passion, enthusiasm, and endless energy can do the most good. His recognition by ASLA is long overdue and I recommend him highly for this honor.
