Summary of Recommendations and Suggestions

Recommendations Affecting Accreditation

- 1. Initiate the process of long-range planning for the program's continued development by the new permanent Program Director (Standard 1).
- 2. Include in the strategic or long range plan information on faculty hiring both in terms of the rate of expansion and areas of focus (Standard 1).
- 3. Appoint a permanent MLA program director credentialed in Landscape Architecture (standard 2).
- 4. To complement and complete the program's emphasis on emerging technologies and innovative design strategies, adjust course offerings to ensure that students learn basic design implementation skills such as detailing and practical applications of grading for stormwater and circulation (Standard 3).

Suggestions for Improvements

- 1. Add additional tenure-track or tenured faculty to support program growth (Standard 2).
- 2. Hold MLA program faculty meetings (Standard 2).
- 3. Encourage a more active student ASLA chapter (Standard 4).
- 4. Hold regular meetings for curriculum review (Standard 5).
- 5. Carefully monitor the teaching/research/service workload balance for tenure earning faculty (Standard 5).
- 6. Encourage self-promotion at the Program level of service learning and other public outreach activities, with emphasis on institutional reporting (Standard 6).
- 7. Constitute an advisory board specific to landscape architecture (Standard 6).
