Dear President Dye:

I am writing in support of the Illinois Chapter of the ASLA's joint nomination of the Chicago Park District and City of Chicago for a 2009 Landscape Architecture Medal of Excellence.

Throughout my career, I have worked with both agencies on numerous open space initiatives. Most recently in my role as the director of the Chicago Area Office of The Trust for Public Land, I have been assisting both agencies on the acquisition of new properties and funding for park improvements with a particular focus on underserved neighborhoods. TPL is currently the coordinator for the Bloomingdale Collaborative, which was an outgrowth of the Logan Square Open Space Plan. The collaborative consists of twenty organizations and agencies committed to the creation of the Bloomingdale Trail, a 3-mile elevated linear trail/park that will repurpose an unused freight rail line. **Re: Nomination of Mayor Richard M. Daley for 2009 LaGasse Medal**


Dear President Dye:
