Please describe the nominee's achievements of national or international significance or influence and how they have benefited the profession of landscape architecture (no more than two pages, single-spaced, typed).

Mr. Rynd has served as Executive Director of the National Building Museum (NBM) for ten years and has strengthened and broadened the Museum's programming to specifically advance landscape architecture. During his tenure, the diversity of programs has exponentially increased including lectures and exhibitions addressing the multi-pronged areas of practice landscape architects address today.

The NBM now provides CEU units for landscape architects providing requisite professional development programming critical for landscape architects to maintain licensure. These outstanding professional development programs have brought to DC, leading thinkers and practitioners of our time, further advancing landscape architectural practice and promotion of the profession.

NBM serves as an example of creative innovation under Mr. Rynd's leadership. Lectures, exhibits, workshop symposia as well as children's education and outreach, all combined have addressed landscape architecture. Sustainability and green building including smart growth, storm water management, and transportation alternatives are education programs advancing the visibility of landscape architects. Urban design, an integral component of landscape architecture practice is notably a constant of NBM programs as is education about new technologies in design practice.

Mr. Rynd advances the landscape architecture profession beyond the NBM. He is active in building and development projects around the District. He participated in the development of programming for the 14th Street corridor and the Columbia Heights neighborhood. He has also taken a role in the Southwest neighborhood development in concert with the National Capital Planning Commission, both areas, examples of the participation and leadership of landscape architects at the local level. Many NBM exhibitions have traveled and gone on to advance the profession of landscape architecture and role of landscape architects nationally and internationally.

We learn from the past and Mr. Rynd has promoted the importance of landscape architecture history and cultural landscapes through programs addressing historic preservation including the initiation of the profession in the U.S. by Frederick Law Olmsted.

For 2013, I know of no other allied professional more deserving of membership. May the selection committee include Mr. Rynd in this year's selection and continue cross partnering to advance our shared mission and goals. Mr. Rynd's exemplary leadership advances landscape architecture. Let us honor his leadership with Honorary Membership in the American Society of Landscape Architects.



For high school students, the Museum now offers in-depth workshops for teens that highlight the many professional opportunities related to the built environment.

In the six plus years that I have served as Chief Librarian for DC Public Library, Chase has been one of my strongest supporters in the community, helping communicate the vital role that architecture and sustainable design play in the health and vitality of communities. Chase and the National Building Museum have served as a critical partner for DC Public Library as we worked to transform the 26-building system, rebuilding or renovating 14 buildings. The Museum organized construction tours of our buildings, which helped raise the profile of the library and the environmentally sustainable aspects of these projects. His strong support and advocacy early on, laid the groundwork for broader community support and ultimately set a high design bar for future projects that the community has now come to expect.
