Bill Callaway has 40 years of experience in the profession of landscape architecture (38) of those with SWA Group). He grew up in the agricultural landscape of California's Central Valley and developed a deep appreciation for the land. He joined SWA in 1967 as a draftsman, eventually becoming managing principal of the Sausalito office, and ultimately president, and then CEO of the company. Over the years, he has worked on many award-winning projects at a wide range of scales—from thousands of square feet to thousands of acres—both nationally and internationally. Breaking the typical CEO mold, he remains an active, hands-on designer, devoting about two-thirds of his time to working on projects, considering himself first and foremost a design principal. Just as importantly he has been mentor and friend to many eminently successful designers, and has helped to mold SWA into a design leader among larger landscape architecture and planning firms. His personal leadership, charisma, and professional passion have inspired many designers to retain an idealistic view of the profession and the world. He has been dedicated to creating a company environment and culture that is humanistic, egalitarian, participatory and supportive of professionals, with attention to fairness, openness and widespread participation in company earnings and professional opportunities. Bill has excelled as both a designer and a company leader.

Bill became president of SWA in 1988 and CEO in 1996. He confirmed and invigorated the company's commitment to excellence in design by steering organizational structure, policies, meetings, communications and the selection of company leadership away from business and full-steam ahead toward professional commitment and contribution. As quoted in *World Architecture*, Bill once said "SWA Group is organized around creativity rather than business. We define creativity as innovative planning and design, but also as the practical addition of value to a project." And under his leadership and nurturing, the firm has continued to embrace this ethos. Bill has been intent on providing a springboard for professionals in the firm to pursue their own visions and practices—this has resulted in a dynamic expansion of work throughout the country and world, and has resulted in increasingly significant contributions in the critical arenas of natural systems and sustainability. Because of his egalitarian, collegial philosophy and approach, Bill has been able to keep some of the most talented landscape architects in the country committed to the group practice of SWA for many years.
