CHAIR-ELECT CANDIDATES



Marq Truscott, FASLA California Sierra Chapter

Marq has practiced landscape architecture for over 30 years, and is licensed in the states of California and Nevada. He is President of Quadriga Landscape Architecture and Planning, an urban design and landscape architecture firm with offices in Sacramento, Santa Rosa, and San Francisco, California. In addition to managing Quadriga, he lectures for the landscape architecture program at the University of California, Davis and serves on their Advisory Board. A member of the American Society of Landscape Architects (ASLA) for almost three decades, Marq has held many positions at the chapter, state and national levels. Marq is also serving as President of the Arts and Business Council of Sacramento, and as a Planning Commissioner for the City of Davis. A graduate of California State Polytechnic University at Pomona, Marq's enthusiasm and collaborative nature drive Quadriga's daily operations. He is deeply interested in the function of landscape architecture in the development of community. Marq routinely shares his conviction and enthusiasm with emerging professionals, which he finds especially rewarding.



Cleve Turner, FASLA Texas Chapter


Cleve is the Founding Principal of Turner LandArchitecture, a landscape architecture, planning and site design firm and has been in private practice for over 38 years. He is a graduate of Texas A&M University with degrees in both Landscape Architecture and Pre Law/Economics, is an Outstanding Alumni of the College of Architecture at Texas A&M and is a member of the Department of Landscape Architecture Urban Planning Professional Advisory Board there. Mr. Turner has served two terms on the Texas Board of Architectural Examiners as its Vice Chairman and as President of the Council of Landscape Architectural Registration Boards (CLARB) & Foundation. Cleve was actively involved in moving the Landscape Architectural Registration Exam from its former paper and pencil format to its current computer based delivery system. As President of CLARB, he also helped to establish continuing education standards for licensure and CLARB's participation as a founding partner of the LACES program. For his leadership to the profession, Cleve was awarded both the Distinguished Service and Distinguished Member Awards by the ASLA Texas Chapter.

SECRETARY CANDIDATES



Terry Clements, FASLA Virginia Chapter

Terry, Professor and Chair of the Landscape Architecture Program at Virginia Tech, is a native Mainiac who discovered landscape architecture from a plant and soils professor at the University of Maine. She has served national ASLA as Vice President of Education, delegate to IFLA, Chapter Trustee, and as a member of the Public Policy Committee, Committee on Education, and Licensure Committee. Terry also served as Secretary and President of CELA, and currently holds a gubernatorial appointment to the Capitol Square Preservation Council in Richmond. She has served as faculty advisor to the Virginia Tech student chapter for many years, and as university liaison to the Virginia chapter; and is currently coordinating the VA ASLA's professional awards program and fall conference. She has received a CELA teaching excellence award as well as the VT Alumni Award for Teaching Excellence. Her research explores women in landscape architecture, landscape experience, cultural landscape studies, and design education.



Bernie Dahl, FASLA Indiana Chapter

As a career academic practitioner, Professor Dahl continuously advocates for students and for quality education. Bernie got a quality education at lowa State University where he earned his BSLA and at Purdue where he earned his MS in Natural Resources. He is an Associate Professor of Landscape Architecture at Purdue and served as Chairman of the Landscape Architecture Program from 2001 to 2007. He is a registered landscape architect in the State of Indiana with a small practice focused on parks, trails and greenways. Bernie has been a member of ASLA since he was a student and has served on both the chapter and national levels. In 2015 Professor Dahl was inducted into the Academy of Fellows of the Council of Educators in Landscape Architecture for his service to CELA and his commitment to service learning in his teaching career. He has been a member of the Landscape Architectural Accreditation Board from 2004 to 2010, with the final year as its chair and continues to serve on its Roster of Visiting Evaluators, participating on over a dozen visiting teams, eight as chair.
