The Society and the profession of landscape architecture are much better off as a result their association with Julia M. Lent—an association now in its tenth year. Having worked with Julia at a state level on licensure issues, as a committee chair, as a VP of Government Affairs, and now as president, I have witnessed her commitment to our causes, her insight to the political context within which we reside, and her understanding of how to accomplish the work that needs to get accomplished on our behalf. To have watched our growth, to have seen how much we have learned, to have become better advocates, and to have seen us accomplish all that we have accomplished alongside of her makes this such a privilege for me to nominate her for honorary membership in our Society.

As Director, Government Affairs for ASLA, Julia is the principal staff person of the team that leads us in the shaping of our public affairs programs and strategies. Julia's background is principally in the area of state government affairs, where prior to joining ASLA she spent ten (10) years as an advocate for state legislative issues ranging from health care to other related issues such as workman's compensation. After receiving a BA in Political Science and her Master's degree in Public Administration from the University of Pittsburgh, she began her career as part of the Legislative Development Office of the Pennsylvania House of Representatives.

She came to ASLA hiring on as a Manager for State Government Affairs in June of 2001 and immediately became involved with our efforts to attain licensure in all fifty (50) states. I first met Julia in Boise, Idaho in the winter of 2002 at a legislative breakfast that was a kickoff for Idaho's licensure law upgrade. I remember thinking at the time that if ever there was a person to help us produce the results needed to accomplish our goals, she was the one. As the 50 by 2010 campaign accelerated and we began to see success after success, always there, hand-in-hand with each successful state legislative team was Julia Lent.

Her influence, her ability produce success in partnership with us and her accomplishments led to her promotion to Director of Government affairs in 2005. Continuing in her role as the principal staff person involved with the 50 by 2010 effort, we have witnessed the growth and evolution of the licensure summits and the attainment of our goal in the summer of 2010. She also exports persistence and tenacity. Even in the darkest moments associated with the legislative efforts in Colorado and Vermont, Julia never lost her optimism and when the licensure teams in both states rallied for one last attempt, she was at their side providing much needed counsel and advice. She is much respected and admired by the chapters and was made an honorary member of the Vermont Chapter in the summer of 2010.

In addition to all this, Julia also works with the VP of government affairs to shepherd three of the four GA committees—Policy, Licensure and LARE Preparation. This is no small task to scope the monthly issues, prepare the material, coordinate with the VP and the committee chair and endure the idiosyncrasies of the committee dynamic—times three. She does endure and does so with grace, dignity and the utmost of respect and patience.

- Continued partnership and management for success in our annual Advocacy Day
- Re-energizing and re-purposing the LARE Prep Committee
- Successful introduction and use of the advocacy network at both a federal and state level

It has been my privilege to work with Julia in two different capacities since she began assisting ASLA with government affairs over ten years ago. As a member and Chair of the ASLA Licensing Committee, I have seen Julia organize, educate, and motivate landscape architects to effectively advocate for their profession and their values. She began her work with the Committee about the same time that the 50 by 2010 campaign began. She took charge of the effort. Julia has been the consistent organizer of this Committee and its work on 50 by 2010, gathering and disseminating information, representing ASLA with our sister organizations, writing reports and papers, and organizing ASLA's yearly Licensing/Advocacy Summit. Her work was the backbone of the support those chapters that faced licensing challenges in the 50 by 2010 got from ASLA.
