Re: Nomination of Deborah Weintraub for Honorary ASLA Membership

Dear Honorary Membership Review Committee:

I am deeply pleased to write this letter of nomination for Deborah Weintraub to be an honorary member of the ASLA. I can think of no better candidate. As the highest-ranking architect in the City of Los Angeles, and the first architect and woman to serve as the Chief Deputy Engineer, Deborah has tirelessly championed open space projects and the role of design in shaping the city's infrastructure in the public realm. She has engaged landscape architects in many of the city's most significant infrastructure and open space projects including revitalization and restoration of the Los Angeles River, the 6<sup>th</sup> Street Viaduct Bridge and P.A.R.C., the Silver Lake Reservoir master plan, the Taylor Yard conversion, and numerous neighborhood parks.

As examples of her initiatives, Deborah's efforts convinced City leaders to view the 6<sup>th</sup> Street Viaduct Bridge replacement as a landscape design opportunity, not just a typical bridge replacement project, which led to an international design competition to convert this infrastructural need into a public amenity, including a new twelve-acre park. Her advocacy resulted in a highly awarded bridge and park, now under construction, that will link diverse communities and create a much-needed open space destination for adjacent underserved neighborhoods. The Taylor Yard project will repurpose a former rail yard and 42 acres of polluted land into a habitat rich public park adjacent to the LA River, and the 2000-acre Sepulveda Basin in the San Fernando Valley will be converted to a public park and flood control landscape.

In addition to specific projects, Deborah has led the City's initiatives in sustainability policies, including the LEED certifications process for the City of Los Angeles – for many years the largest municipal Green Building program in the country, and the adoption of Envision for civil and landscape architectural projects. She has also been a frequent participant and speaker in local and national forums including the ASLA, the Natural Resources Defense Council, the U.S. Green Building Council, and the U.S. Army Corps of Engineers.

Deborah has engaged in educational programs, and initiated a partnership with Alexander Robinson, ASLA, Professor in the USC School of Architecture + Urbanism, to create a physical hydraulic model of the LA River at Taylor Yard that will be used to test river flows and channel alterations. She is also a frequently invited critic for studio reviews including for the University of California at Los Angeles, University of Southern California,

In summary, Deborah's achievements, actions, and influence have significantly supported the landscape architecture profession, and from her platform in the second largest city in the nation, she has furthered the recognition that landscape architects can be leaders in the transformation of the public realm into a more sustainable, equitable, and resilient landscape. I give her my highest recommendation to be recognized as an honorary member of the ASLA.

I am writing to endorse the nomination of Deborah Weintraub as an Honorary member of the American Society of Landscape Architects. Deborah's commitment to the improvement of the public realm and public service makes her the ideal candidate for honorary membership in the ASLA. As Chief Architect and Chief Deputy Engineer for the City of Los Angeles and an Architect by training, Deborah spends her days working to improve the open space networks, parks, infrastructure, and community facilities for over four million Angelenos. Her influence resonates daily not just in Los Angeles' parks and facilities but nationwide, as various agencies and government's view LA's leadership as the standard bearer for design excellence.

As Chief Architect and Chief Deputy City Engineer, Deborah represents the client's side on the Sepulveda Basin Vision Plan in the City of Los Angeles, and we have had the opportunity to collaborate on various LA River initiatives over the course of many years. At the 2,000-acre Sepulveda Basin we are, together, reimagining the future of the park as a nature-based, resilient park for the San Fernando Valley. The basin is the second largest park in the city, and the largest if excluding parks with extensive mountainous areas. The mainstem of the Los Angeles River flows through the basin and is heavily channelized. The plan proposes to restore the river, creating enhanced habitat and improved recreation. Deborah's vision, fortitude, and commitment are admirable as she navigates the complexity of city, county, state, and federal governments to achieve a more equitable, more just, and more environmentally sustainable civic realm at the basin.

Deborah has dedicated decades to public service, which is often a thankless position. In her role she oversees and ensures successful and thoughtful public engagement as part of projects, coordinates with regional Tribal leaders, liaises with elected officials and non-profits, and manages a complex team of planners, architects, and engineers. Her track record of complex and intricate projects is exemplified in projects such as the award-winning, internationally acclaimed 6<sup>th</sup> Street Bridge in LA and the Los Angeles LA River Revitalization Master Plan. She oversees the LEED certifications for the City of LA as well as the City's Public Buildings and Open Spaces Design and Construction Program.

Through her work providing executive and design leadership for facilities for the unhoused she is helping with the homelessness crisis across 15 City Council Districts in LA. Her leadership extends to countless parks projects including projects at Spring Street, Echo Park, Silver Lake, Taylor Yard, and North Atwater Park, just to name a few. Her list of achievements on behalf of public open space is staggering.

As a fellow female leader, I am incredibly impressed by Deborah's achievements as a leader in the often male-dominated professions of architecture and engineering. She is the first female and first architect to ever serve as Chief Deputy City Engineer, a testament to her incredible leadership. And, while she has received several national and local awards recognizing her leadership, she is never too busy to join a student review or help an academic department. I teach at the University of Southern California in the Department of Landscape Architecture where Deborah is incredibly supportive of the students and faculty. One of my former Master of Landscape Architecture students later realized during a major city meeting how incredibly important Deborah is and remarked, "Oh my goodness! I emailed her so many questions about my project when I was a student, and she answered all of them. I had no idea she was the Chief Deputy Engineer – she was so patient and kind to me." This sort of testimony demonstrates what I think is the most impressive quality of Deborah: her kindness, thoughtfulness, and commitment to the landscape of the city is unparalleled.

As a leader in the field of Landscape Architecture and member of the American Society of Landscape Architects, I cannot think of another individual currently that is more qualified than Deborah to receive the Honorary ASLA membership. It is my honor to nominate Deborah Weintraub, Chief Architect and Chief Deputy City Engineer, for Honorary Membership in the American Society of Landscape Architects (ASLA). Over the past 23 years of service to the City of Los Angeles Deborah has consistently demonstrated an unparalleled commitment to the environment and public open space.

I first came to know Deborah in 2006 when I joined the City of Los Angeles' Department of City Planning. In my new role I had the pleasure of working directly with Deborah and her team at the Bureau of Engineering on the City's Los Angeles River Revitalization Master Plan (LARRMP). That experience allowed me to experience firsthand Deborah's leadership in championing a multi-disciplinary dialogue that coalesced community groups, political leadership, and environmental stewards around a groundbreaking plan for the Los Angeles River. These are large, complex projects that will take years to implement and require navigating complicated funding structures, political hurdles, community concerns, and environmental remediation. I am confident that under Deborah's continued leadership these projects will come to fruition. These projects are just a sample of the kinds of projects that Deborah has shepherded during her long tenure at the city. This unwavering support for the environment and open space is the reason I am firm in my endorsement of Deborah Weintraub for Honorary Membership in ASLA.
