

32 33 Sec. 1. 32 MRSA §220, sub-§2, ¶B, as repealed and replaced by PL 2009, c. 415, Pt. A, §16, is amended by amending subparagraph (1) to read:

- (1) To Except as otherwise provided in this chapter, to be qualified for admission to the examination a license to practice landscape architecture in this State, an applicant must submit evidence to the board that the applicant has passed an examination administered by a national council of landscape architectural registration boards or an equivalent examination specified by board rule and:
 - (a) The applicant has completed a course of study in a school or college of landscape architecture approved by the board, with graduation evidenced by a diploma setting forth a satisfactory degree, and 2 years of practical experience in landscape architectural work of a grade and character satisfactory to as prescribed by the board by rule; or
 - (b) The applicant has training or practical experience, or a combination of both, that in the opinion of the board is fully equivalent to that required in division (a).





Freedom to Invest in Tomorrow's Workforce Act (H.R. 1477/S. 722)

- Introduced on March 8, 2023 by Reps. Wittman (R-VA) and Spanberger (D-VA) and Sens.
 Klobuchar (D-MN) and Braun (R-IN)
- Expands eligible expenses under 529 savings plans to cover postsecondary costs including:
 - Licensure prep courses, practice exams, and study materials
 - Licensure exams
 - Continuing education and licensure renewal
 - Other costs required to obtain and maintain a license

Cosponsor H.R. 1477, the Freedom to Invest in Tomorrow's Workforce Act

Message Body

As your constituent, I urge you to cosponsor H.R. 1477, the Freedom to Invest in Tomorrow's Workforce Act. This bill would help reduce the various costs and fees associated with being a licensed professional such as a landscape architect. Alleviating financial burdens associated with licensure helps to promote career growth and allows licensed individuals to retain more disposable income.

Specifically, this measure would expand eligible expenses under 529 savings plans to cover costs associated with workforce training and credentialing programs, including government issued professional licenses. Notably, it would enable landscape architecture professionals to use 529 plans to help cover licensure costs and fees associated with licensure exam prep courses and study materials; licensure exams; continuing education and licensure renewal; and other costs necessary to obtain and maintain a license.

Licensure for landscape architects provides a broad base of protection to public health, safety, and welfare. Landscape architects plan and design open spaces such as streets, parks, plazas, campuses, and other active public areas. Each of these sites must account for a variety of potential hazards. Significant physical and financial harm has occurred when landscape architectural projects were not designed by licensed professionals. While the public is best served by licensed landscape architects, there are considerable financial costs of achieving and maintaining licensure. This bill would help to reduce these costs.

Once again, I urge you to cosponsor H.R. 1477, the Freedom to Invest in Tomorrow's Workforce Act.

Petition Text

Dear Senators Klobuchar and Braun and Representatives Spanberger and Wittman:

We, the undersigned advocates of the American Society of Landscape Architects (ASLA) write to thank you for your leadership in introducing the Freedom to Invest in Tomorrow's Workforce Act. (S.722/ H.R. 1477). This legislation would help cover the expenses associated with being a licensed professional such as a landscape architect.

As you know, 529 savings plans do not currently cover expenses related to postsecondary credentials and skills training that are required for many professions, including landscape architecture. This is significant because the average cost to obtain initial landscape architecture licensure is about \$3,500. Then, the average cost to maintain licensure, including annual continuing education, is around \$750 per year. For landscape architects, the financial relief created through this measure would make an incredible difference in our ability to achieve and maintain our licensure requirements.

Making licensure for landscape architects more affordable will help enlarge the pool of professionals qualified to protect public health, safety, and welfare. Landscape architects plan and design open spaces such as streets, parks, plazas, campuses, and other active public areas. Each of these sites must account for a variety of potential hazards. Significant physical and financial harm has occurred when landscape architectural projects were not designed by licensed professionals. This bill would help ensure our communities are responsibly planned and designed to protect people of all ages, abilities, and socioeconomic backgrounds.

Once again, we thank you for your leadership in sponsoring the Freedom to Invest in Tomorrow's Workforce Act. Landscape architects belong to one of many professions that are eager to pay forward the benefits of this legislation.
