The Landscape Architectural Accreditation Board (LAAB) at its July 20-21, 2017 meeting granted accreditation for a period of six (6) years to the course of study leading to the first professional BLA degree at Louisiana State University. This status is subject to review of annual reports and maintenance of good standing.

Accreditation is awarded on a time-certain basis. The six-year period of accreditation ends June 30, 2023. Accordingly, the BLA program is next scheduled for a review during the spring of 2023.

In making its decision, LAAB considered the program's self-evaluation report, the visiting team report, the institution's response to the team report, and discussions with team members and program faculty.

Enclosed is a list of recommendations affecting accreditation (to be responded to in annual reports). This list was developed by LAAB from the materials reviewed during the meeting.

SUMMARY OF RECOMMENDATIONS

Recommendations Affecting Accreditation

- 1. The program has an unfilled position for a part-time Associate Director and should consider the benefits of distributing some of the administrative duties currently filled by the Director and releasing the Director to concentrate on the critical administrative and development needs of the Program (Standard 2).
- 2. The program should enhance its faculty development program with the goal of introducing and acclimating new hires to the culture of the program and advancing faculty from the rank of Assistant Professor to Associate Professor and faculty from the Associate Professor ranks (Standard 2).
- 3. The school should review its multiple measures approach to curriculum assessment and clearly communicate its process and outcomes (Standard 3).
