<u>Congressman David Price</u> represents North Carolina's Research Triangle that includes Raleigh, Cary, Durham, Chapel Hill, and surrounding communities. He was elected to Congress in 1986 and has served 12 terms.

Price currently serves on the House Appropriations Committee and serves as the Ranking Democrat on the Homeland Security Appropriations Subcommittee, which oversees funding for the Department of Homeland Security. He is a member of the Appropriations Subcommittees responsible for housing, transportation, military construction and veterans' affairs appropriations.

Congressman Price has been a long-time supporter of ASLA, its members, and legislative priorities, including active transportation, green infrastructure, and urban parks legislation. Since 2007, Congressman Price has personally met with landscape architects as part of ASLA's Advocacy Day and In-District Advocacy Day. After meeting with landscape architects from his district and reviewing their legislative requests, Congressman Price has consistently agreed to sponsor ASLA-supported legislation including: the Green Infrastructure for Clean Water Act; the Urban Revitalization and Livable Communities Act; Complete Streets legislation; and supported efforts to fund the Historic American Landscapes Survey. Congressman Price's staff works diligently with ASLA to support the Society's legislative priorities and attends ASLA-sponsored briefings, hearings, and green roof tours.

Congressman Price is a true advocate for multi-modal transportation policies and has stated "I am a strong supporter of "smart growth" development, which emphasizes greater coordination of housing, public transportation, and economic development plans at the local level, as well as an advocate for a "complete streets" policy that improves transportation options for all users — including pedestrians, bicyclists, transit riders, older persons, individuals with disabilities, and motorists. I have worked with local leaders to advance a plan for expanded bus and regional rail, and have also helped lead the fight in Congress to expand and improve high-speed rail in critical corridors, including the Southeast. We simply must develop a true multi-modal transportation strategy in order to keep pace with our community's needs."

Price also strongly supports efforts to protect the environment, promote wise stewardship of our natural resources, ensure clean air and water, and address climate change. Congressman Price has teamed with other representatives working to advance legislation that preserve the scenic Blue Ridge Parkway for generations to come. He has also successfully passed legislation to modernize the system for tracking hazardous waste. In addition, Price continues working to maintain a safe and adequate drinking water supply for Fourth District residents. He was instrumental in compelling the Army Corps of Engineers to raise the Falls Lake dam level to ensure Raleigh's future water supply and has helped secure grants for stream restoration and wastewater processing in North Carolina communities.

Congressman Price received his undergraduate degree at UNC-Chapel Hill and went on to Yale University to earn a Bachelor of Divinity as well as a Ph.D. in Political Science. Before he began serving in Congress in 1987, Price was a professor of Political Science and Public Policy at Duke University. He is the author of four books on Congress and the American political system.

As a champion of legislative issues important to the American Society of Landscape Architects, along with his passion for active transportation issues, sustainable development and green infrastructure, Rep. David Price is an excellent candidate for honorary ASLA membership.
