To whom it may concern:

This letter is written in support of the nomination of Chicago's Mayor Richard J. Daley for the Alfred LaGasse Medal. No other mayor of a large American city has demonstrated the leadership and concern for the conservation of natural resources and public lands that Mayor Daley has shown throughout his long tenure—now twenty years. During this period Chicago has emerged as a global leader in urban ecology and greening. Mayor Daley has expressed a vision that transcends beautification, embracing concepts of biodiversity and ecological sustainability that demonstrate how nature and wildlife can co-exist in a metropolitan center with a large human population. His vision has given concrete expression to the idea that the metropolitan fabric can be green, habitable and "humane".

Early in his tenure, Mayor Daley launched "Mayor Daley's GreenStreets" which has led to the revitalization of Chicago's parks and boulevards and the planting of over half a million treesenriching the lives of millions of residents, reducing heat islands and creating new habitat. Chicago is one of few cities in the United States, if not the world, that has a mayoral committee on nature and wildlife, which brings together government agencies and not-forprofits to advise the mayor on opportunities to improve and increase habitat for nature and wildlife across the city. This committee, which I chair, conducted an inventory of important city lands-over 4,800 acres of prairies, savannas, dunes, woodlands, wetlands and potential restoration sites throughout Chicago-and developed a plan that lays out a framework for protecting and enhancing these areas. The plan was adopted by the Chicago Plan Commission and sets the stage toward making Chicago a place where people and nature live in harmony.

Mayor Daley has established two major initiatives involving multiple city agencies and regional non-profits to institutionalize and build broad constituencies for conservation and conservation education. The two initiatives are: 1) Growing School Gardens with the goal of establishing school gardens connected to curriculum in all Chicago public schools by 2018 and 2) the Urban Tree Initiative, which also establishes collaborative partnerships among multiple public and private groups to increase Chicago's tree canopy as part of its pioneering Climate Action Plan. These are but two concrete examples of Mayor Daley's vision put into practice.

I could list countless other examples of how Mayor Daley has added significant new greenspace to the city's system of parks, gardens and natural areas, how he has adopted the Chicago River as Chicago's forgotten waterfront, and how students and residents have embraced nature in the city and become committed stewards of our natural environment. Mayor Daley has inspired a new generation of civic leaders who in the spirit of Daniel Burnham have joined him in making Chicago America's greenest city. I can think of no one more deserving of the ASLA's Alfred LaGasse Medal than our visionary mayor and hope that you will award him this coveted price in 2009-- the centennial of the world-famous Burnham-Bennett Plan of Chicago.

This letter enthusiastically supports the nomination of Chicago Mayor Richard Daley for the American Society of Landscape Architect's 2009 Lagasse Medal. Through visionary leadership, personal commitment, and innovative management, Mayor Daley has transformed the old industrial Chicago into a vibrant green city. Daniel Burnham would be proud.

Through my position as Regional Executive Director of the National Wildlife Federation's Great Lakes Regional Center, I have had the privilege of working with the Mayor and his staff on a project that demonstrates his leadership and innovation. Through the Mayor's efforts, the city of Chicago has just committed to greening every one of the 600 Chicago public schools – both their physical plant and the knowledge they impart to their students. The Mayor is launching a Growing School Gardens Initiative that will provide each student in Chicago with access to outdoor learning landscapes at their schools. The project will ensure that every school has a garden – a food garden, a natural habitat, a butterfly garden, a bioswale, or a campus park – that is integrated with the school's curriculum. No other official in the nation – or the world – has done so much to conserve green landscapes in such an industrial location.
