

Bill Nelson is a true son of Florida, his family coming to the Panhandle in 1829; and, his grandparents homesteading in the early 20th Century on land that today is the Kennedy Space Center.

From a spot near there Bill would launch into space in 1986 and spend six days orbiting the Earth aboard the space shuttle Columbia.

Nearly three decades later, he still vividly recalls looking back at our planet from the window of the shuttle and not seeing any political, religious or racial divides.

"From that perspective, you can see how we're all in this together," he says. "If we could just remember that, we'd sure get a lot more done."

It's that kind of perspective that has earned Bill a reputation as a thoughtful, moderate voice in an increasingly partisan political world.

Nelson's public service career began in 1972 with his election to the Florida Legislature. He then served six terms in the U.S. Congress representing Orlando and the Space Coast becoming an early champion of the environment.

In 1994, Nelson was elected to the Florida Cabinet as state Treasurer, Insurance Commissioner and Fire Marshal. During his six years in the post, he showed he was a common-sense problem solver and strong consumer advocate.

Nelson was first elected to the U.S. Senate in November 2000. He stood up to the insurance companies, Wall Street banks and Big Oil. He exposed the lies of BP about the Gulf spill. And he created a blueprint forward for our nation's space agency. Now in his third term, he is continuing to fight for lower taxes, better education, Medicare and Social Security.

In 2010 the United Nations put the Florida Everglades back on the list of the world's most endangered treasures thanks to a multi-year push led by Senator Nelson who pressed the group that keeps the list; the U.N. Educational, Scientific and Cultural Organization.



He is someone who believes public service is a noble calling which is why he's devoted his life to serving his community, his state and his country.

Here are examples of his dedication to and love of our environment:

**Offshore Drilling:** Senator Nelson has worked consistently to keep offshore drilling away from Florida's coast in order to protect the state's tourism-driven economy, its unique environment and the country's vital military testing and training areas in the Gulf of Mexico.

He blocked Senate drilling legislation until it provided adequate protections for Florida, including a 125-mile buffer off the Panhandle and a 235-mile no-drilling zone off most of the state's west coast. In addition, he was able to obtain written assurances from Senate leaders that they will not allow pro-drilling House members to weaken these important protections.

While the Senate bill adequately protects Florida's interests, Senator Nelson believes the real solution to high gas prices is to conserve energy and continue developing alternative fuels.

**Arctic National Wildlife Reserve (ANWR):** Senator Nelson opposes drilling in the Arctic Refuge. The United States has approximately 3 percent of the world's oil reserves, meaning there is no way to drill our way out of the current energy crisis. Instead, we must increase our energy efficiency and develop alternative fuels. Additionally, when the Senate voted to open drilling in ANWR, he felt that it was inappropriate to include an ANWR drilling provision in a defense spending bill.

Securing Funds for Florida Conservation Projects: Senator Nelson secured \$140 million in 2006 federal funds for Florida conservation projects. This sum includes \$137 million for the on-going Everglades Restoration and \$3 million to help the state purchase and preserve Babcock Ranch. Babcock Ranch, one of the last pristine wildlife corridors in the state of Florida, is approximately 91,000 acres of forest and swamp land in Charlotte and Lee counties and is home to many species of wildlife, including the endangered Florida panther. He continues to work for additional conservation money including pushing the Senate leadership to consider an important bill that would help fund projects to improve the water quality of the Indian, Stuart, and Calooshatchee rivers.

**Arsenic in Wood and Drinking Water:** Responding to concerns about health risks from arsenic-laced playground wood, Nelson introduced legislation to protect children by banning all arsenic-treated wood products offered for sale in the U.S. Dozens of parks around Florida closed because of reports on elevated levels of arsenic in the soil around wooden playground equipment.

Soon after Nelson's push to eliminate arsenic in treated wood, the EPA and the wood-preserving industry agreed to phase out the use of arsenic in residential wood. However, industrial uses for chromate copper arsenate (CCA) weren't included in the phaseout leaving many workers still at risk.

**Superfund:** Nelson helped start a five-year study of the health affects of pollutants in the Pensacola area. The city and surrounding area is home to several major Superfund sites. He also is helping Jacksonville with the clean up of neighborhoods polluted by waste from city incinerators. In south Lake County, Nelson is trying to help residents who live near the old Tower Chemical Co. plant, one of the nation's oldest Superfund sites, get water filters to protect them from the chemicals still leaking into the ground.

During ASLA Advocacy Day visits, the Senator and his staff have always welcomed us, actively listened and responded favorably to our requests. Collectively, they have a long record of supporting our profession. Bill, himself, truly understands and appreciates Landscape Architects and Landscape Architecture. We hope to have the privilege of welcoming him to our Society.
